The terms of the agreement are as follows:

#### **Article 1:**

The two aforesaid parties wish to enable cooperation and exchange in all academic areas of mutual interest, namely teaching, administrative management and research.

#### **Article 2:**

The purpose of this general agreement can include, but is not limited to the following:

- Diploma recognition in all the fields of study of the two parties
- Exchange of research and teaching personnel
- Exchange of students
- Academic and research programs
- Double diploma programs
- All administrative management tasks of mutual interest

#### **Article 3:**

With the implementation of the present agreement, a yearly work program shall be set up in order to determine among others: the subject concerned, the work schedule, the number of students exchanged and the duration of the exchanges. Any plans for future collaboration in a given academic field shall be contract to a written agreement with reference to the present document

**Article 4:**

With regard to the exchanges of professors and researchers, the payment of the traveling and stay expenses will be processed individually.

**Article 5:**

With regard to the exchange of students, the precise exchange conditions (number of students, levels, validation of the studies in the host university, registration) shall be subjected to an amendment to the present agreement.

**Article 6:**

Both parties shall be held responsible for making sure that any participant in the exchange is in a regular situation with regard to the host country legislation: visas, social security, civil liability insurance...

**Article 7:**

The two parties shall be held responsible for obtaining necessary funding for the development of projects undertaken within the framework of the present agreement. Financial arrangements shall be submitted to the appropriate authorities for approval.

**Article 8:**


The present agreement covers an initial period of five academic years and shall take immediate effect upon signature by the two parties. Either party may request changes to and/or cancellation of the present agreement by giving six months' prior notice. In that case, the actions in hand shall be brought to completion.

**Article 9:**

The present agreement is made in triplicate in English, each copy being deemed authentic.
